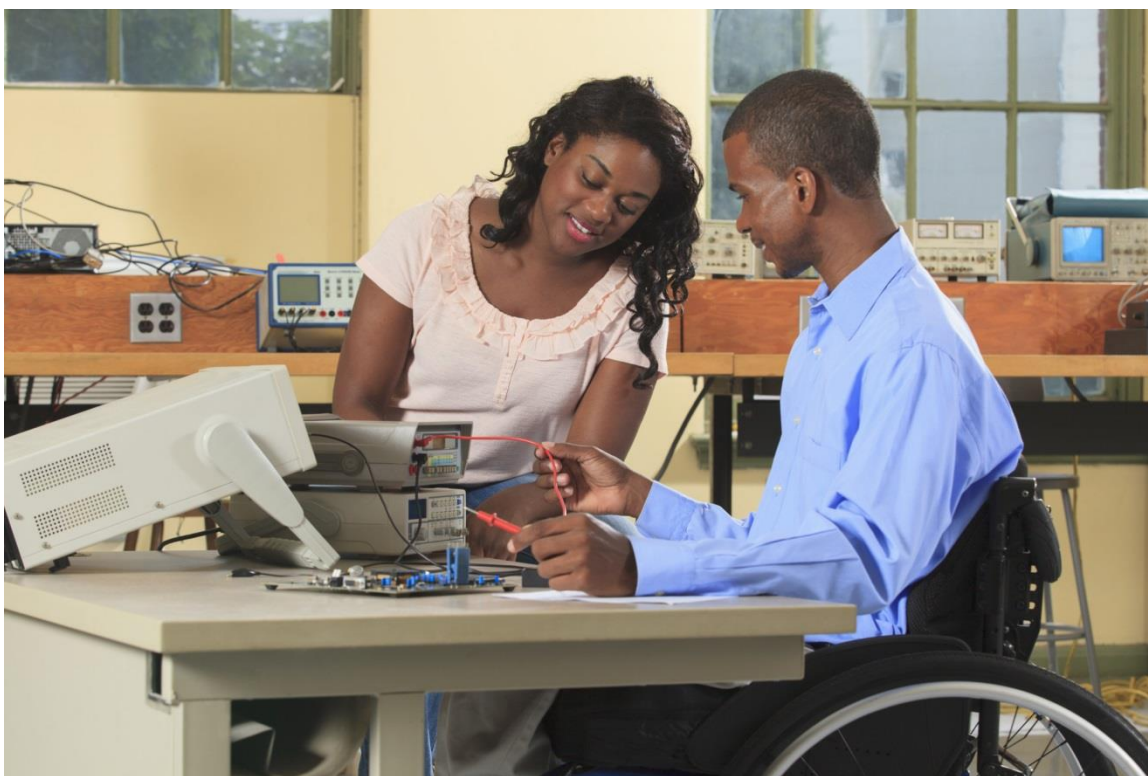


# Vocational Rehabilitation



Every state has a federally funded agency that administers vocational rehabilitation (VR), and supported employment. VR assists people in finding jobs through local searches and by promoting self-employment and telecommuting opportunities. VR services vary widely depending on the state but typically include medical, psychological and vocational assessments; counseling and guidance; vocational and other types of training; interpreter and reader services; services to family members; rehabilitation technology; placement; post-employment services; and/or other goods and services necessary to achieve rehab objectives and secure employment. In some cases, VR may pay for transportation and vehicle modification. There is a vocational rehabilitation office in each state as well as county or regional VR offices in each state.
