

## **Team Reeve Terms & Conditions for the 2025 TCS New York City Marathon**

### **Entry Fee & Fundraising Requirements**

The Team Reeve NYC Marathon Minimum Fundraising Requirement is \$6,000 for all new participants (\$5,000 for previous Team Reeve athletes) and the participant is required to pay the NYC Marathon registration fee which is \$315 for non-NYRR members. It is the expectation of all team members to continue fundraising even if they exceed their fundraising commitment before the marathon. The fundraising deadline is November 2<sup>nd</sup>, 2025 unless otherwise stipulated by the Team Reeve manager and agreed to by participant in writing. In the event the participant does not meet the minimum fundraising requirement by the date outlined above, the Christopher & Dana Reeve Foundation will charge the remaining fundraising balance owed to the participant's credit card. If \$3,000 is not raised by October 3<sup>rd</sup>, 2025, the Team Reeve manager may charge the remaining fundraising balance to participant's card on file. We accept Visa, MasterCard, American Express and Discover. If credit card on file fails and team member does not provide alternate source of payment, they may be banned from participating in future World Major Marathon events.

### **Participant will complete the below to be fully registered on Team Reeve:**

1. Participant reads, signs, and emails completed contract back to Team Reeve manager at Klamb@Reeve.org.
2. Participant must set up custom Team Reeve fundraising page via Classy fundraising platform within 3 days of receiving instructions from the Team Reeve Manager. Participant will not receive the NYC Marathon registration link until their fundraising page is set up and then confirm via email it has been completed to the team manager.
3. Participant must complete separate 2025 New York Road Runners Marathon registration link to be provided from Team Reeve manager within 3 days of receiving instructions. Participant is not confirmed on the team until all of these steps are completed.

### **Cancellation Policy**

After official acceptance on the 2025 team, participant will be responsible for raising a minimum of \$6,000 (\$5,000 for previous team members) by November 2<sup>nd</sup>, 2025 even if participant chooses to cancel their participation for ANY reason. This includes injury, family circumstance, etc. The NYC Marathon does allow charity runners to defer their entries if done so before November 1<sup>st</sup>, 2025. All team members are required to hit their fundraising minimum regardless of their circumstances and if they need to defer their entry.

### **Donations & Fundraising**

Any donations received by the Christopher & Dana Reeve Foundation/Team Reeve will not be returned. Participants are expected to be consistently fundraising and communicating their fundraising progress/strategy with the Team Reeve manager when asked from the time they are accepted to the team through marathon weekend. The Team Reeve manager has the discretion to cancel their event entry before the registration deadline and assign to another participant on the Team Reeve waitlist. The Team Reeve manager reserves the right to charge the remaining fundraising balance to a participant if the registration deadline has passed and they have stopped communicating with the team manager or if they have stopped actively fundraising for the event.

In consideration of accepting this entry, participant hereby for themselves, heirs, executors and administrators, waive and release any and all rights and claims for damages they may have against the Christopher & Dana Reeve Foundation, Team Reeve, other foundation consultants and event sponsors for any, and all potential injuries suffered by participant in said event. Participant attests and certifies they are physically fit, will sufficiently train for competition in this event, and a licensed medical doctor can verify their physical condition if needed. Participant grants permission for use of their name and/or photograph or voice in broadcast, telecast, print or any other account of this event. If accepted on the marathon team, participant agrees to collect the required fundraising minimum for the Christopher & Dana Reeve Foundation by stipulated deadline. If participant has not reached the minimum in sponsorship by that date, they will be personally responsible for the balance owed and will ensure their credit card information provided is current and active to charge the remaining balance.
